

<u>General Eligibility</u>. The following general criteria will be used to determine eligibility for consideration for The Reagan Legacy Foundation Scholarship:

- The applicant/recipient must be: 1) an Active Duty Sailor or member of the Airwing serving aboard USS Ronald Reagan as of the application deadline; or 2) the spouse, Registered Domestic Partner, child or dependent of an Active Duty Sailor or member of the Airwing serving aboard USS Ronald Reagan as of the application deadline. "Dependent" is defined as a high school senior or undergraduate student under the age of 24 who is single and has no children. Only one scholarship per family will be awarded in any 12 month period.
- The applicant/recipient must be enrolled in a college, university, vocational or trade school. Students pursuing degrees or professional certifications on-line are eligible.
- Applicant/recipient shall be a full-time or part-time student.
- The applicant/recipient shall have: 1) a minimum of 2.0 grade point average on a 4.0 scale or equivalent (letter grade of C), or 2) demonstrate a commitment to future academic performance.
- The applicant must be a US citizen or legal US permanent resident at the time this application is submitted.

Selection Criteria. The Reagan Legacy Foundation Scholarship Program shall not discriminate on the basis of race, color, gender, national or ethnic origin, or religious preference. The criteria for determining scholarship selectees shall be based on the following:

- Financial need.
- Academic achievement or demonstrated commitment to future academic performance.
- Demonstrated leadership and extra-curricular activities.
- A brief written essay about President Ronald Reagan.

Number and Value of Reagan Legacy Foundation Scholarships. The Reagan Legacy Foundation will award a certain number of scholarships in such a dollar amount as to best meet the objectives of The Reagan Legacy Foundation without jeopardizing the foundation's financial stability and long-term goals. Each individual scholarship shall not exceed \$1,000. The Reagan Legacy Foundation is not obligated to award scholarships if, in its opinion, there is not a sufficient number of fully-qualified candidates to justify making such awards.

Award of Other Scholarships to Applicants/Recipients of Reagan Legacy Foundation Scholarships. The Reagan Legacy Foundation scholarships are based on four distinctly different criteria. As such, the receipt of a scholarship award from another source should not in itself disqualify an applicant from receiving a Reagan Legacy Foundation Scholarship. As a rule, however, acceptance of scholarship aid from other sources that in the selection committee's opinion constitutes a "full scholarship" will eliminate the applicant from consideration. Full scholarship in this case includes tuition, room, board, and fees.

Application Evaluation. Score sheets are provided for each selection committee member to record the score for each application reviewed. The score sheet will include a comments section that will enable committee members to record comments and determine evaluations. The maximum point values for each of the four selection criteria are:

Financial Need	8 points
Academic Achievement/Goals	6 points
Leadership/Extracurricular Activities	6 points
Written Essay	5 points
Total	25 points

- 1) Financial Need: The applicant or applicant sponsor's income documentation (IRS Form 1040) and the income/expenses and asset/liability information within the application will be used to determine financial need.
- 2) Academic Achievement/Goals: Applicant shall have a minimum 2.0 grade point average on a 4.0 scale or equivalent (letter grade of C) or demonstrate a commitment to future academic performance. Applicant should provide appropriate verification such as high school standardized test scores (SAT, ACT), GED certificate, high school or college transcripts.
- 3) Leadership/Extracurricular Activities: Extracurricular activities are an excellent indicator of the applicant's involvement in school, community and military service. Quality of participation will be rated over quantity. Emphasis will be placed on leadership roles held.
- 4) Written Essay: Because the character and presidency of Ronald Reagan serves as the inspiration for The Reagan Legacy Foundation, it is important that scholarship recipients possess a general knowledge of his life. Scholarship applicants shall write a brief essay (no more than two pages) about President Ronald Reagan. The specific subject matter will be determined by the Scholarship Selection Committee and may vary in each application cycle.

Failure to provide appropriate verification documents will result in a lower evaluation score. The Reagan Legacy Foundation and Scholarship Selection Committee may request further documentation from the applicant. Submitted applications and Selection Committee score sheets are confidential property of The Reagan Legacy Foundation.

The Reagan Legacy Foundation is a non-profit, charitable organization founded by Michael Reagan, son of former President Ronald Reagan.
